Establishment of a Medical School with On-Campus Teaching Hospital

An Integrated Healthcare and Education Investment Opportunity

The Government of Maldives invites investors to participate in the establishment of a **state-of-the-art Medical School with an integrated, on-campus Teaching Hospital**. This flagship project is designed to strengthen the national healthcare workforce and reduce reliance on overseas medical training and treatment. With a growing number of school leavers seeking high-quality, locally accessible medical education, the project addresses a critical and growing national demand.

Financial viability is further reinforced by the inclusion of a fully operational hospital, strategically located in a **fast-growing urban area underserved by tertiary healthcare services**—offering strong revenue potential from clinical services, specialist care, and diagnostics.

This initiative presents a **compelling opportunity to invest in the future of education and healthcare in the Maldives**, with clear pathways for sustainable returns and long-term impact.

Project Overview

Located in Hulhumalé Phase 2 – the fastest-growing urban and residential area in the Maldives – the project site spans 69,912.28 sqft. It will function as a commercial medical school integrated with a fully operational multi-specialty teaching hospital, offering:

- Inpatient and outpatient care
 - Emergency and diagnostic services
 - Surgical and specialist medical services
- Designed to support both public healthcare and medical education, the facility will serve as a hub for students, patients, and medical professionals, making it a sustainable and high-impact investment.

Scope of Development

- Multi-specialty teaching hospital with full clinical services
- Modern lecture halls and clinical training spaces
- Advanced simulation centres, laboratories, and ICT infrastructure
- Faculty and administration offices, consultation rooms, seminar halls
- Integration of academic and hospital functions to support hands-on learning

Key Investment Highlights

- 1. Strategic Location:** Hulhumalé Phase 2 is a planned smart city and residential hub
- 2. First-Mover Advantage:** No similar integrated project exists in the country
- 3. Dual Revenue Streams:** Education (tuition fees, partnerships) and Health Services (inpatient, diagnostics, specialist care)

4. Public-Private Partnership Models Available:

- o Invest and Operate: Medical school to be operated jointly with **Maldives National University (MNU)**; investor may operate hospital under agreed terms
- o Contractor Finance: Government open to EPC models with extended payment terms

5. Land Allocation: Land is currently assigned to MNU and can be made available on a **long-term lease at concessional rates** under approved terms

Implementation Details

- **Construction Timeline:** 720 days (24 months)
- **Lead Focal Agency:** Maldives National University (MNU)
